NJ Graduation Proficiency Assessment

- Statute requires the State graduation proficiency assessment to be administered to all 11th grade students (N.J.S.A. 18A:7C-6).
- Designed to measure the extent to which students are graduation ready in ELA and Math.
- ELA is aligned to Grade 10 Standards
- Math is aligned to Algebra I and Geometry Standards.
- Graduation readiness is reported separately for each component.
- A score of 725 or greater is required to demonstrate proficiency in both ELA and Math.
- Should a student's score fall below the cut score for ELA and/or Math, there are alternate pathways to demonstrate proficiency.

FIRST Pathway

Achieve greater than or equal to cut score in each subject area:

NJGPA ≥ 725 in ELA

NJGPA > 725 in Math

If the cut off score was not achieved during the Spring '23 assessment, students will have the opportunity for a retake in the Fall.

Second Pathway

Demonstrate proficiency in ELA and/or Math by meeting the designated cut score on one of the substitute assessments below:

THIRD PATHWAY

Demonstrate proficiency in ELA and/or Math through a portfolio appeal, which includes:

- Student transcripts and the intervention plan for the student
- Performance on state and substitute competency assessments
- Constructed-Response Tasks in the subject area(s) in which the student has not yet attained proficiency
 - The CRT's are designed, administered, and graded locally
 - The CRT's are designed for students to demonstrate competency in ELA and/or Math in alignment with the state standards

WHAT IS ACCESS?

- ➤ The ACCESS test is a tool used to measure English

 Language Learners Proficiency in the English

 Language
- > Students are assessed in 4 Domains:
 - o Speaking, Listening, Reading, Writing

KPS Data

- > 8 Students total, Grade Levels K-5
- > Each of the 4 Domains are assessed on a proficiency level of 1-6
- 1=Entering knows & uses minimal social & academic language
- 2=Emerging knows & uses some social & general academic language
- 3=Developing knows & uses social English & some specific academic language
- 4=<u>Expanding</u> knows & uses social English & some technical academic language
- 5=Bridging knows & uses social and academic language with grade level material
- 6=Reaching knows & uses social & academic language at the highest level
- measured by this test

EXIT Criteria

Overall score = 4.5 or greater

Summative of all 4 components (Reading,

Listening, Speaking, Writing)

3 Students were found eligible to exit ESL services
