XIII. BOARD MEMBER COMMENTS

Mr. Petruccelli – We do have local control of what goes into the curriculum. Parental choice to opt-out. The Board of Education has talked about this process.

Mr. Gigante – There are multiple tasks here. Many of the items in the curriculum are necessary now. A lot is included.

Mr. Eisenmenger – Parent to three sons. There has always been an opt-out option in all the subjects. Commend the community for all the participation. There is a policy in place #2240 for controversial issues.

Mrs. Fischbeck - There is not a lot to add. Confident with the teachers in the district.

Mrs. Parrella – This is not an easy decision. Hesitation in the lower grades.

Dr. Riscica –Resource slides are for teachers to develop lesson plans, not for students. Sometimes teachers go rogue. If a teacher does, there are steps that we take. It is all going to take time.

Mrs. Fischbeck – Values come from your home. Have trust for all involved.

Mrs. Donaldson – Litigation issues about not adopting curriculum. Board Attorney reviewed potential measures. Explained QSAC and corrective action plan.

Mr. Petruccelli – Teacher PD as this is rolled out.

Mrs. Donaldson – The state approves the standards, the district develops the curriculum.

Dr. Riscica – Consequences for students if this is not voted upon.

Mrs. Parrella – Dr. Riscica and Mrs. Mulholland worked extremely hard on this.
