A. EDUCATION COMMITTEE

- The Kinnelon Board of Education, upon the recommendation of the Superintendent, approves the appointment of Carly Pena to the position of Replacement Guidance Counselor at Stonybrook School, M.A. Degree, Step 1, at a salary of \$57,635 (pro-rated), effective October 15, 2013 through March 14, 2014. This action is pending successful completion of all required criminal history background checks and approval by the New Jersey Department of Education.

The Kinnelon Board of Education, upon the recommendation of the Superintendent, approves the appointment of Gary Vesper to the position of Replacement Social Studies Teacher at Kinnelon High School, M.A. Degree, Step 1, (pending transcript review), at a salary of \$57,635 (pro-rated), effective November 13, 2013 through January 21, 2014.
